DEGREE OF MASTER OF PHILOSOPHY, SPECIAL EDUCATION: VISUAL IMPAIRMENT/ HEARING IMPAIRMENT/ MENTAL RETARDATION (M.Phil: Special Education: VI/ HI/ MR) (With effect from the academic year- 2010-11)

1. Preamble:

The M.Phil Special Education (Visual Impairment /Hearing Impairment / Mental Retardation) Degree Course will be conducted at Ramakrishna Mission Vivekananda University in the Department of Disability Management and Special Education in accordance with the provisions of these regulations and subject to the conditions laid here under.

2. Eligibility

The minimum qualification for admission is M.Ed Special Education (Visual Impairment/ Hearing Impairment/ Mental Retardation) securing a minimum aggregate of 55% marks. In case of SC/ST Students it shall be 50%. Admission to the M.Phil Special Education (VI/ HI/ MR) course will be through a written entrance test in the subject.

3. Admission:

The admission to the M.Phil Special Education (VI/HI/ MR) is based on the merit at the entrance test and subject to various reservations in force.

A candidate who is admitted to M.Phil Special Education (VI/ HI/ MR) shall not pursue any other course or appear for any other examinations leading to any other degree of Ramakrishna Mission Vivekananda University or any other university, failing which his/or her admission shall be cancelled.

4. Duration

It is a full time course and candidates registered for the course should study for a period of one academic year as full time research scholars.

5. Course of study

The course of study for the M.Phil degree shall consists of

- a) Part I comprising three written papers according to the syllabi duly approved by the Chairmen of the Board of studies concerned from time to time: and
- b) Part II – Dissertation.

Part: I shall consist of Paper I-Trends in educational development

Paper II- Research methodology and statistics

Paper III- Back-ground paper relating to the proposed dissertation

The candidates are required to put in a minimum of 80 % attendance in Part.1.

Those who do not fulfill this condition will not be permitted to appear for part.1 examination.

6. Duration of the course;

The M.Phil Special Education Course (VI/ HI/ MR) will be of one academic year (10 months) duration. instruction for part.1 (paper 1 and 2) shall be completed within 5 months from the date of commencement of the course.

Instruction for Paper III, the back-ground paper relating to the proposed dissertation, shall be completed during the 6th to 8th month of the course after the submission of the proposal for the dissertation.

7. Scheme of Examination

Part I- Written Examination- Papers 1 and 2

The examination for papers 1 and 2 shall be held at the end of the 5th month after commencement of the course.

The examination for paper 3 shall be conducted by the end of 9th month before the submission of the dissertation.

The duration for each paper shall be 3 hours carrying 100 marks each

The question paper setters shall be appointed from the standing list of examiners approved by the department of examination of the University

The written papers shall be valued by two external examiners

If both the examiners have given pass marks and the difference is not more than 15 percent, candidates shall be declared to have passed in written paper by taking the average of the two valuations.

If both the examiners have awarded fail marks and the difference is more than 15 percent, the written paper shall be referred to third examiner and the third valuation shall be final.

If one examiner gives pass marks and the other examiner gives fail marks, the written paper may be referred to third examiner irrespective of the difference and the third valuation shall be final.

If both the examiners have awarded fail marks, irrespective of any difference, the candidates shall be declared to have failed in written paper.

Part II – Dissertation

The exact title of the dissertation shall be intimated within three months from the commencement of the course. Candidates shall submit the dissertation to the University through the guide at the end of one year which shall be valued by internal examiner (guide) and one external examiner appointed by the University from a panel of four names sent by the guide through the Dean.

Submission or re-submission of dissertation shall be once in a year.

8. Passing Minimum

- i) A candidate shall be declared to have passed Part I of the examination if he/she secures not less than 50% of the marks in each paper.
- ii) A candidate shall be declared to have passed Part II of the examination if he/she secures not less than 50% of the marks in internal and external.
- iii) All other candidates shall be declared to have failed in the examinations

iv) Viva-voce

In case the candidate secures not less than 50% of the marks in internal and external

the controller of Examination will initiate action for conducting the viva-voce examination. It will be conducted by a Board constituted by RKMV University.

A copy of every approved M.Phil Special Education (VI/ HI/ MR) dissertation shall be placed in RKMV University library.

9. Restriction in number of changes

No candidate shall be permitted to re-appear for the written examination in any paper or more than two occasions or to re-submit a dissertation more than once. Candidates shall have to qualify for the degree passing all the written papers, dissertation within a period of three years from the date of commencement of the course.

10. Conferment of the degree

No candidate shall be eligible for conferment of the M.Phil Degree in Special Education (Visual Impairment/ Hearing Impairment/Mental Retardation) unless he/she is declared to have passed both the parts of the examination as per the Regulations.

11. Qualification for persons conducting the M.Phil Course

No teacher shall be recognized as a Supervisor unless he/she possesses a Ph.D Degree in Education or two years of Post-Graduate teaching experience after qualifying for M.Phil Degree in Education
